

HUMAN RIGHTS POLICY STATEMENT

PURPOSE

The Human Rights Policy Statement of ECN Capital Corp. (together with its affiliates and subsidiaries, the "Corporation") formalizes the Corporation's commitment to uphold, protect and promote human rights for all people.
