**ECN Capital Announces Closing of \$75 Million Offering of
6.00% Senior Unsecured Debentures**

Toronto, Canada – October 28, 2021 – ECN Capital Corp. (TSX: ECN) (“**ECN Capital**”) today announced that it has closed the previously announced offering (the “**Offering**”) of \$75 million aggregate principal amount of senior unsecured debentures due December 31, 2026 (the “**Debentures**”). The Offering was conducted by a syndicate of underwriters co-led by BMO Capital Markets, CIBC Capital Markets, National Bank Financial Inc. and RBC Capital Markets, and including TD Securities Inc., Raymond James Ltd., Cormark Securities Inc. and Stifel GMP (collectively, the “**Underwriters**”). ECN Capital has also granted the Underwriters an option to purchase up to an additional \$11.25 million aggregate principal amount of Debentures, on the same terms and conditions, exercisable in whole or in part, for a period of 30 days following closing of the Offering.

The Debentures bear interest at a rate of 6.00% per annum, payable semi-annually in arrears on June 30 and December 31 of each year, with the first interest payment on December 31, 2021. The Debentures will mature on December 31, 2026.

ECN Capital intends to use the net proceeds from the sale of the Debentures to redeem or repay outstanding securities and/or indebtedness and for general corporate purposes.

The Debentures will commence trading today on the Toronto Stock Exchange under the symbol “ECN.DB.A”. Further details concerning the Offering are set out in ECN Capital's prospectus supplement dated October 21, 2021, available on SEDAR at www.sedar.com
